SPECIAL CONDITIONS OF SALE

EARS CONFUSION MARKS ON SHEEP, CATTLE AND PIGS.

Consigners must intimate at time of Sale if any animals have Ears mutilated with marks of any description making them ineligible for Certification under the Fatstock Guarantee Scheme.

COMPLAINTS IN RESPECT OF RIGGS, RAMS OR MUTILATED EARS

Any complaints in respect of Riggs, Rams or improperly castrated sheep or sheep with right ears mutilated with marks of any description which will render them liable for rejection under the Fatstock Guarantee Scheme must be intimated to the Auctioneers within 10 days of date of sale. Thereafter no claim arising therefrom will be entertained.

Should a Weaned Heifer Calf prove to be in-calf, the Seller must be prepared to compensate the Buyer to the extent of one-third of the cost price.

Back Calvers and Spring Calvers coming in-season within 49 days of the date of Sale may be rejected. Intimation, in writing, to the Auctioneers within that period to the effect that the animal is not in-calf shall entitle the purchaser to return the animal to the exposor and recover from him the price thereof together with keep and transport expenses duo.

CORRECT MOUTHED EWE.

A Ewe shall be considered "correct in mouth" where there are six centre teeth or more firmly in position and together.
