I refer to your letter of 2nd. January, 1973 requesting information of the above Air-Strip for publication in 'Air Cargo Industry'.

The Winter Air scheduled flights were withdrawn as at 6th December, 1973, although I understand that this will not affect the Summer scheduled flights. Perhaps it would be advisable for you to contact the Transport Division Highlands and Islands Development Board at Bridge House, 27, Bank Street, Inverness 1V1 10R regarding information of the Summer Scheduled Flights as they are responsible for the inauguration of the flights.

The Air-Strip is operated under an Ordinary Aerodrome Licence, there are no customs facilities available, no re-fuelling, and only for day use.

Private aircraft may use the strip on early notification being given to this office - landing fees at present 30p per 1,000lb weight.

Should you require any additional information I shall be glad to help you.
