Dear Sir/Madam,

The 1957 wool clip has been of record size. It is expected to total about 75 million lbs.-the largest clip for 18 years, and about 10% more than that of last year.

Not only has more wool been produced, but it has also been presented in better condition and the proportion of wools of above average value has increased. Because of these last two factors the Board has paid to producers about $\frac{3}{4}d$. per lb. more than the figure used as the basis for the 1957 price schedule.

While wool production during the past year has been most encouraging, market prices have declined. The fall in wool values in world markets between October, 1957 and January, 1958 has inevitably affected prices realised by British wool, although not to the same extent as merino wool prices. At the time of writing the wool trade is still rather unsettled, but the relationship of world supply and consumption is still healthy provided that the solution of international difficulties restores confidence in the trade.

The Board's efforts to promote the sale of products made from British wool are now well under way, and in this work the Board is materially assisted by the International Wool Secretariat. In the end, the price we receive for our wool is related to the demand of the public for wool products. In these days of severe competition from man-made fibres you will be helping yourself, as a wool grower, if you impress on others that THERE IS NO SUBSTITUTE FOR WOOL.

BRITISH WOOL MARKETING BOARD

Schedule of Maximum Prices for Wool delivered in accordance with the Board's Instructions during the period May 1st, 1958 to January 31st, 1959

(NOT GRADED)

The following Schedule of maximum prices is published by the Board pursuant to Paragraph 72 of the British Wool Marketing Scheme, 1950.

Part I.

1. The maximum prices to be paid for wool (other than skin wool) which is duly tendered in the period 1st May, 1958 to 31st January, 1959, by the producer thereof are given in Part II. of the Schedule. These prices shall also apply to wool delivered with the Board's consent between 1st February, 1959 and 30th April, 1959 but such deliveries shall be subject to such conditions as the Board may prescribe in accordance with the provisions of paragraph 71 (5) of the British Wool Marketing Scheme, 1950. These Schedule prices have been calculated to give effect to an average price of 50.85 pence per pound, and are the maximum prices that will he paid for good clean washed or light greasy wools of the specified types, delivered in accordance with the directions of the Board.

Intermediate and inferior wools will be valued in proportion to maximum prices.

2. The value of each clip will be established by reference to the quality and condition of the wool. Care will be taken to ensure that the efficient producer receives the highest price possible for his particular class of wool, but proportionate reductions will be made in the case of those clips which are inferior in quality or condition or are badly prepared or otherwise not free from fault.

3. The wool covered by paragraph I includes Locks, Broken, Fallen Wool, Tail, Daggings, etc., and each Registered Producer will be informed as to the persons to whom, and the places to which, his wool for sale is to be delivered. It will be to the advantage of producers and assist in securing greater efficiency if there is ready compliance with all directions issued by the Board.

4. Interest at the rate of 7 per cent. per annum will be paid on the value of all wool covered by paragraph 1 which is not delivered before the 1st September 1958 from that date until date of delivery, or 1st December 1958, whichever is earlier, provided that the Board is previously notified of the wool for sale and that delivery is given by the producer within the period specified by the Board.

5. The price to be paid for any wool not covered by paragraph 1 above will be 1d. per lb. but supplementary payments will be made according to circumstances.

Exchequer contribution towards the cost of spreading lime obtained under the provisions of the Agricultural Lime Schemes, 1947/55

1. Contribution towards the cost of spreading lime, delivered on or after the 8th April, 1957, is calculated at a percentage of the actual cost of spreading.

2. Where the supplier spreads the lime, or arranges the spreading, and spreading costs appear in the original application for contribution, the spreading contribution is paid together with the contribution towards the delivered cost. When the occupier does the spreading himself, however, the spreading contribution cannot be made payable to the supplier but only to the occupier direct. Accordingly in such cases the attached green form (ALS/SC2) is sent to the occupier for completion when he has spread the lime. On completion it should be returned to the Agricultural Lime Department showing the actual cost of spreading.

3. To claim the spreading contribution on the attached form (ALS/SC2) the occupier should take care to see that the cost of spreading the lime to which the claim relates is properly shown on the form. No spreading contribution can be made until the actual cost of the spreading has been stated, since it is the actual cost which, subject to certain upper limits, determines the amount of contribution.

Building Grants for Landholders and Cottars in the

Highlands and Islands

Under the Agriculture (Scotland) Act, 1948, grants can be given to landholders and cottars in the Highlands and Islands towards the erection, improvement or rebuilding of dwelling-houses and other buildings. This leaflet gives an outline of the scheme.

1. Who may obtain Grants.—Applications for grant may be made by landholders and cottars as defined in the Small Landholders (Scotland) Acts, 1886-1931, whose holdings are in the counties of Argyll, Caithness, Inverness, Ross and Cromarty, Sutherland, Orkney and Zetland, and who propose to erect, rebuild or improve dwelling-houses or other buildings on their holdings.

2. Amount of Grant.—Applications made on or after 1st November, 1952, may qualify for grant of one-half of the cost of skilled labour and materials as determined by the Secretary of State within the following limits :—

- No grant will be given where the estimated cost of skilled labour and materials is less than £100.
- (2) The grant for a new house or for replacement of an existing house will not exceed £650.
- (3) The grant for improving a house will not exceed £350.
- (4) The grant for erecting, replacing or improving farm buildings will not exceed £250.

3. Conditions of Grant.—The Landholders and Cottars (Building Grant) (Scotland) Regulations 1949 (Statutory Instrument 1949 No. 946 (S. 56)) as amended by the Landholders and Cottars (Building Grant) (Scotland) Amendment Regulations 1950 (Statutory Instrument 1950 No. 1304 (S. 96)) set out conditions applicable to grants offered and made under the scheme. Copies of the Regulations may be purchased from H. M. Stationery Office, 13a Castle Street, Edinburgh, 2, or through any bookseller (price 3d. post free).

The following is a summary of the conditions as they affect landholders and cottars:-

(1) Authorised grants will be made by the Secretary of State either by payment in one sum on completion of the work to his satisfaction or in instalments as the work proceeds, as he may determine.

(2) The works must be completed to the satisfaction of the Secretary of State in accordance with the proposals approved by him at the time he decided to make a grant, and in the event of failure to comply with this condition the Secretary of State may withdraw the grant and recover any payments of grant that may have been made.

(3) Where a grant has been made for the erection or replacement of a house or farm building, the landholder or cottar and his successors will be under obligation for a period of forty years to maintain the house fit for human habitation and the farm building fit for agricultural use, and to keep the house or building fully insured against destruction or damage by fire.

(4) Where the grant is given for the purposes of improvement only, the same conditions will apply for a period of twenty years.

(5) During the same periods the landholder or cottar will not be allowed to sub-let the house or farm building for which a grant has been given except with the consent of the Secretary of State.

(6) In the event of a breach of the conditions mentioned at (3), (4) and (5) above, the landholder or cottar may be required to repay a proportion of the grant with interest at the rate of $3\frac{1}{2}$ per cent. per annum, as provided in the Regulations.

(7) The landholder or cottar will be entitled to obtain release from these conditions on repaying to the Secretary of State a proportion of the grant with interest, as in (6) above.

(8) If at any time within the periods stated in (3) and (4) above, compensation becomes payable under the Small Landholders (Scotland) Acts for a house or building in respect of which a grant has To be completed and returned to the appropriate Area Office of the Department of Agriculture for Scotland, together with a rough sketch plan of the proposed work.

 - (a) Motor fuel acquired against these coupons must not be used for the whole or any part of a journey for which the use of public transport is practicable.
 - (b) The registration number of the vehicle specified in the application must be entered on the coupon before it is surrendered for motor fuel.
 - (c) The coupons are not transferable and any remaining unused must be returned to this office when-
 - (i) they cease to be valid;
 - (ii) the purpose indicated on the application ceases to apply; or

(iii) the vehicle in respect of which they have been issued ceases to be licensed, which ever occurs first.

(2) F coupons

- (a) Motor fuel acquired against these coupons may not be used in any vehicle used under a licence marked "Private," or for which an issue of A : B coupons has been made.
- (b) The name of the applicant must be entered on each coupon which must be signed by him or on his behalf at or before the time of supply of fuel.
- (c) Coupons are not transferable and any remaining unused must be returned to this office when they cease to be valid.

The return of coupons will not prejudice future applications.

4. Application for motor fuel for the next rationing period should be made on the form printed overleaf on or after a date to be announced later. **REGISTRATION BOOKS FOR VEHICLES SHOULD BE ENCLOSED WITH THE APPLICATION.**

5. Diesel oil is not rationed by coupon for use in stationary engines or vehicles not licensed to run on public roads. Such engines or vehicles operating on diesel oil should not, therefore, be included in your application.

WHAT TO DO NOW

1. Write your address on the cover of your new ration book. On a Green Ration Book R.B.2, see that the holder's date of birth has been entered.

 You must copy the names and addresses of your present retailers from page 6 of your old ration book on page 6 of the new book. You will not need to re-register with retailers, nor for cheap or free milk under the Welfare Foods Service.

3. The normal facilities under which consumers may change retailers every 8 weeks have been suspended from 23rd March until 17th May except for Welfare milk.

SPECIAL FOOD ALLOWANCES

 SPECIAL MEAT COUPONS (R.G.44) : If you hold these coupons you can use them only with the butcher with whom you are registered.

5. TEA FOR PERSONS OVER 70 (R.G.64): The new coupons have been issued with the new ration books. If you are entitled to them and have not received them, please apply to the Food Office.

6. EXTRA EGGS FOR BABIES: Extra eggs are allowed for children between the ages of six months and two years. If you have a child who is not already getting them, you should apply to the Food Office, taking or sending the child's ration book.

7. OTHER SPECIAL ALLOWANCES : If you are receiving a special allowance of rationed food, there will be a Form R.G.48 or R.G.48E affixed to page 5 of your old ration book. If a similar form was not issued with your new ration book, and you wish to have the special allowance continued, you should apply to the Food Office. Before doing so, be sure to obtain any certificate required as shown below :

(a) INVALIDS (R.G.48): If the Form R.G.48 in your old ration book expires on or before 18th May, 1952, but not otherwise, you will need to obtain a fresh Medical
