Under Separate I am directed to state, for the information of the Town Council that the Air Council have under consideration the establishment, in the position indicated on the enclosed plan, of an air firing and bombing range at Dornoch Firth and Tarbat Ness in respect of which it is proposed to make Byelaws providing for the use of the Range at all times of the day and night throughout the year. I am writing to you in connection with the use of the Royal Air Force Armament range at Tain. As you are aware this range has so far not been in use on Sundays and public holidays. In imposing this restriction on the use of the range the Air Council were actuated by a desire to interfere as little as possible with the amenities of the neighbourhood, and in particular by their recognition of the fact that the use of the range on Sundays would be unwelcome to a number of the local residents. The outbreak of war has naturally affected the position and I feel that it is now incumbent upon me to authorise the necessary amendment to the existing bye-laws to permit of the use of the range throughout the year. I am, however, considering whether it would be possible to restrict the use of the range during the hours of Divine Service.

I feel sure that the members of your Council will appreciate the special circumstances and I should be grateful if you would take an early opportunity of bringing my letter to their notice.


