MEMORANDUM ON THE PROVISIONS OF THE LOTTERIES AND AMUSEMENTS ACT, 1976

The Act authorizes the conduct of small lotteries for purposes other than private gain by societies (which includes clubs, institutions, organizations or branches of these) for raising money for charitable, sporting and other purposes. Under the Act the following conditions must be observed in connection with the promotion and conduct of such lotteries: (a) the promoter must be a member of the society and be authorized in writing by the governing body of the society to act as such; (b) no remuneration must be paid to the promoter for conducting the lottery; (c) no prize must exceed £1,000 and the price of any ticket or chance shall not exceed 25p; (d) the whole proceeds after deduction of lawful expenses (not exceeding 25 per cent. of the proceeds) and the provision of prizes (not exceeding one-half of the proceeds) must be applied for the purposes of the society; (e) the price of every ticket must be the same and shall be stated on the ticket; (f) the total value of the tickets sold must not exceed £5,000; (g) no written notice or advertisement of the lottery is allowed except within the premises of the society or distributed exclusively to members thereof; (h) every ticket must specify the name of the society, the name and address of the promoter and the date on which the determination of the prizewinners will take place; (i) no payment on account of expenses or prizes must be made out of the moneys of the society not being proceeds of the lottery; (1) no ticket to be sold by or to a person under 16 years of age.

Any breach of the foregoing conditions is deemed to be an offence.

The society must be registered with the Local Authority in whose area the office of the society is situated—the registration fee is £10. Power is given under Part I of Schedule 1 of the Act to refuse to register a society or to revoke its registration after giving the society an opportunity of being heard. A right of appeal to the Sheriff is given.

Under Part II of said Schedule I the promoter of a lottery must make a return,* certified by two other members of the society. Such a return is to be deposited at the office of the Local Authority for one year and may be inspected by members of the public free of charge. Failure to make a return or making a false return is an offence punishable by a fine not exceeding £400.

ONE-DAY SALES

At a recent meeting of the appropriate Committee of the District Council, the Council had under consideration the matter of one-day sales by visiting traders. The matter is not one which directly affects the Council in respect that the Council do not have premises which one-day traders seek to use for their sales and therefore there was no direct action which the Council could take in the matter. A number of members did, however, refer to the fact that they understood that such one-day sales were, from time to time, held in village halls. Members took the view that such sales could be said to be prejudicial to shopkeepers in respect that shopkeepers were permanent features of a community who paid rates, etc and who therefore make a positive contribution to their local community. Members felt that one-day traders did not make this contribution but nevertheless stood to obtain some benefit from their sales which might possibly be at the expense of permanent shopkeepers. Since members believed that village halls were from time to time used for these sales, I was instructed to draw your attention to the matter and to suggest that your Hall Committee consider very carefully whether they would wish their hall to be used for these purposes. While the matter is clearly one for your Hall Committee to finally determine, the Committee did feel that you would wish to carefully consider the situation having particular regard to any possible prejudice that local shopkeepers might suffer as a result of such one-day sales.

The decision of the Committee in the matter has now been approved by the District Council and I am therefore writing to you in the foregoing terms, as instructed, to draw your attention to the matter.
